

Protestant Preschool & Kindergarten (PP&K)

Parent Contract

2010-2011 School Year

Parents/Legal Guardians of students at PP&K must agree to abide by all policy of the school prior to registration. Several important items are highlighted below, and a complete listing of policy is described in detail in the school handbook, which must be read by parents/legal guardians prior to signing below.

Tuition payments will be made on time, by the 5th of each month, beginning in September and ending in May. All payments will be made by check or money order. A \$10 late fee will be required for any monthly tuition payment received after the 5th day of the month when tuition is due.

The \$100 registration fee is entirely non-refundable and \$50 of that fee will apply to the student's first month of tuition.

Parents are responsible for pick up of children on time, and will be responsible for late pick-up fees of \$10 per child for the five minutes and \$5 per child per each minute thereafter.

A \$25 service charge will be required if any check is returned by a bank. This fee must be paid within 10 days of notification.

"A withdrawal form must be completed to release tuition responsibility. A written 30-day notice must be delivered to the school director in the case of withdrawal. Parents are responsible for tuition from the date of the notice until the expiration of 30 days. Parents are responsible for another month of tuition if this 30-day notice is not provided. Parents are responsible for the tuition as provided herein irregardless of the reason for withdrawal except as specifically set out herein or in the handbook. After April 1st of the school year in which a withdrawal occurs, all unpaid balances will be due immediately upon withdrawal."

Students immunizations should be current and on file in the PP&K office. A medical form must be submitted within the first 2 weeks of the child's annual enrollment at PP&K. Parents are responsible for updating changes on a child's medical form.

Students will arrive no sooner than 5 minutes prior to the stated time for class arrival and will be picked up at appropriate dismissal time. Parents/legal guardians should contact the school office immediately in the event that an emergency prohibits them from arriving for pick up at dismissal.

Students will be potty trained prior to enrollment.

PP&K reserves the right to suspend or dismiss a student at any time during the school year if a student or parent's behavior is in conflict with the environment that is desired by the school. Children or parents who verbally or physically threaten another student or staff member will be immediately removed from the classroom.

Special needs of student should be clearly stated to the school director prior to enrollment.

PP&K is a peanut free school. Peanuts and snacks with other peanut ingredients are strictly prohibited.

Parents will provide transportation for their own child(ren) and will supervise their own child(ren) during school field trips.

PP&K reserves the right to amend the school handbook.
